Admissions Policy

Introduction

As a Voluntary Controlled Church of England School we follow the Norfolk County Council policy for first admissions & in-year admissions to school. Admissions Criteria for Reception

The school will enrol pupils up to its agreed overall capacity and annual admissions limit. By law, children must start statutory education full-time at the beginning of the term following their fifth birthday. Where admission is offered prior to compulsory school age, parents may defer their child's entry into school until later in the academic year or request their child attend on a part-time basis e.g. mornings only.

All children can now start school full time as of the September following their 4th Birthday. At Wreningham VC CE Primary School, we offer parents the choice of full time from the start of term, or part time until October half term or Christmas. Where possible (and appropriate) we encourage parents to choose full time from the start of the autumn term.

At present, our pupil admission number (PAN) is 15 pupils and, where possible, we try to adhere to these numbers across all year groups. Where there are exceptions made, and the number per year group is above 15, careful consideration is made in the years directly below and above, to ensure class sizes are both manageable and able to be accommodated. If required, the Headteacher and governing body will review and adjust the structure of classes across the school, in order to accommodate additional pupils, above our PAN.

The Governing Body does not allow race, religious beliefs, gender, disability or social background to affect its Admission Policy.

Over subscription rules for first admissions.

If there are more applications for places than there are available, we will give preference to children living nearest to the school, according to the following rules in this order of priority:

Children who are due to start school and:

- 1. Have an EHCP (Education Health and Care Plan) which names the school
- 2. Are in public care or have been adopted from public care
- 3. Live in the catchment area and have a sibling attending the school at the time of their admission
- 4. Have a disability and live in the catchment area
- 5. Live in the catchment area
- 6. Live outside the area served by the school who have a brother or sister with an EHCP attending the school at the time of their admission

- 7. Live outside the catchment area who have a sibling attending the school at the time of their admission
- 8. Have a disability and live outside the catchment area
- 9. Children of staff
- a) where a member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made and/or
- b) the member of staff is recruited to fill a vacant post for there is a demonstrable skill shortage
- 10. live outside the catchment area served by the school and have no sibling connection with the school

The school's catchment area is: Wreningham, Ashwellthorpe and Fundenhall.

If all children within any of the above rules cannot be offered a place, the highest priority will be given to children living nearest to the school within that rule. To determine who lives nearest, distance will be measured on a straight line "crow fly" basis, using Ordnance Survey data. The address will be measured from the post office address point on the property. In the unlikely event that distance does not separate the final two or more pupils seeking the last remaining place, a random allocation will be used to determine who is offered the final place.

Joining the School in Reception

Starting school is a very exciting time for pupils and parent. The school will work with parents individually to ensure it is both positive and rewarding. Pupils are admitted to Wreningham VC Primary School in the September of the academic year in which they are 5.

During the previous summer term, children are invited to join us for several 'taster' sessions to support them to become familiar with the routines and environment of the school. There will also be a New Intake meeting where parents will be informed of our day-to-day procedures and what their child(ren) might experience during his/her first few months at school.

In-year Applications (moving schools)

If a family have moved to the area or surrounding area, a place can only be offered in the school if there is one free in their child/children's age group. Parents should always apply for a school place through the Local Authority's School Admissions Team at
