Computing

Intent

Our intent is to provide a computing curriculum which ensures our pupils become digitally literate and digitally resilient: being confident, competent and critical in using digital technology, the internet and social media in a positive, effective, responsible and safe manner. We aim to develop technology users who can analyse problems in computational terms, able to code computer programs in order to solve such problems. They should be equipped with a good understanding of how to apply the fundamental principles and concepts of computer science, including modelling, logic, algorithms and data representation. Technology is ever evolving and we aim to develop pupils who can assimilate new technologies intuitively, creatively and skilfully, whilst being equipped with the knowledge to keep themselves 'safe' as active participants in a digital world.

National Curriculum Purpose of study: A high-quality computing education equips pupils to use computational thinking and creativity to understand and change the world. Computing has deep links with mathematics, science, and design and technology, and provides insights into both natural and artificial systems. The core of computing is computer science, in which pupils are taught the principles of information and computation, how digital systems work, and how to put this knowledge to use through programming. Building on this knowledge and understanding, pupils are equipped to use information technology to create programs, systems and a range of content. Computing also ensures that pupils become digitally literate – able to use, and express themselves and develop their ideas through, information and communication technology – at a level suitable for the future workplace and as active participants in a digital world.

Implementation:

- To ensure high standards of teaching and learning in computing, we implement a curriculum that is progressive throughout the whole school. Our implementation of the computing curriculum is in line with 2014 Primary National Curriculum requirements for KS1 and KS2 and the Foundation Stage Curriculum in England. This provides a broad framework and outlines the knowledge and skills taught in each key stage.
- We use and follow the Purple Mash scheme of work from Year 1-6, ensuring consistency and progression throughout the school. The Purple Mash scheme of work enables clear coverage of the computing curriculum whilst also providing support and CPD for less confident teachers to deliver lessons. The Purple Mash Lessons are broken down into weekly units.
- Units are practical and engaging and allow computing lessons to be hands on.
- We have adopted and tailored the Purple Mash Computing scheme to meet the above intent and National Curriculum requirements and the needs of Wreningham children, using three broad teaching areas to frame the requirements, although there will be cross-over within these areas:

Computer Science - **Information Technology** - **Digital Literacy**

- Units cover a broad range of computing components such as coding, spreadsheets, Internet and Email, Databases, Communication networks, touch typing, animation and online safety.

- Teachers ensure that ICT and computing capability is also achieved through core and foundation subjects and where appropriate and necessary ICT and computing should be incorporated into work for all subjects where possible.
- Through the Purple Mash platform, teachers can deliver thematic, cross curricular lessons that also follow children's interests and provide flexibility.
- Computing teaching is practical and engaging, with children having access to the technology they require.
- Teachers and pupils are aware of the importance of health and safety and pupils are always supervised when using technology and accessing the internet.
- Our pupils are fully encouraged to engage with ICT and technology outside of school through use of Microsoft Teams for online home teaching and access to homework, and online spelling platform, 'Ed Shed-Spelling Shed' for spelling activities on a weekly basis –along with access to Purple Mash from home.
- Each teacher and pupil has their own unique Purple Mash and 'Ed Shed' login and password.
- Computing work can be stored and saved using pupil login details and homework ('2do's' and 'assignments') can also be set for pupils to access and complete tasks at home that link with their current class learning.
- Wreningham uses 'Tapestry' to record the learning journey and evidence of early learning goals for Reception and Year 1 pupils.
- Online safety and safeguarding are taught and revisited throughout the year. Online safety issues both inside and outside of the classroom are taught and discussed. All pupils study a structured, planned online safety unit through their computing lessons. (See progression in online safety displayed in 'Summary and Progression – Digital Literacy' within this document)
- National Safer Internet Day is highlighted in assembly and classes in February.
- Opportunities are sought to invite relevant visitors into school to enhance the quality and visibility of online safety – e.g. 2022 Visit by cyber security advisors from Norfolk Police for KS2.
- Additional online safety teaching is planned and taught during the year in a structured manner through RSHE teaching (See RSHE map).
- Parents are offered opportunities to enhance their understanding of online safety both in and outside of school – e.g. Oct 2022 – Parent Workshop in school.
- Online safety is revisited at the beginning of every term to ensure the knowledge and skills are current.

Impact

- Children are able to build upon previously learnt skills and embed current skills.
- Children have a good understanding of the concepts of computer coding, and could apply these concepts when using unfamiliar coding languages in the future.
- Children become increasingly proficient in the use of technology and have good, transferable knowledge.
- Children have the knowledge and skills to make use of a wide range of technology for communication, presentation, organisation, calculation, design and creativity.
- Children have a clear understanding of online safety, the knowledge to make good choices.
- Children know who to go to when unsure, or in need of help or support, and the means to keep themselves safe online both in and out of school.
- Children understand the importance of being responsible and respectful in the online world.
- Through use of Purple Mash, Microsoft Teams and exposure to a range of software and technology (e.g. Excel, Microsoft Word, laptops, tablets, desktops), children develop a broad base of knowledge and intuitive technological and digital skills which can be utilised when using other similar platforms.
- Children are enthused and engaged in this subject and actively look to use digital technology outside of the taught lessons.

Children know that an unexpected outcome is due to the code they have created and can make logical attempts to fix the code, e.g. Bubbles activity in 2Code.
